UK National Director JOB DESCRIPTION



Mission Statement: BCM International is a global Bible-Centred Ministry dedicated to making disciples of all ages for the Lord Jesus Christ through evangelism, teaching and training, so that churches are established, and the Church is strengthened.

Our Vision: To see children and young people come to know, love and obey God.

Organisation: BCM International UK is a charity registered with the Charity Commission for England and Wales. It is primarily a faith mission, funded through gifts from our supporters and our charitable activities.

BCM International UK's charitable objectives are implemented by a Board of Trustees (the Anchor Trust), a local trust in Scotland (Clyde Valley), a Board of Directors in Northern Ireland, a small group of full-time missionaries, and a large number of volunteers. Missionaries raise their own financial support.

Post: UK National Director

Working hours: approx. 35 hours per week on average (will include some evening and weekend work)

Salary: Personal Support

Reports to: The Anchor Trust

Location: Various areas in the UK, dependent on the circumstances of the successful applicant

Duration: Open-ended/permanent (*pending the successful completion of a 6-month probationary period*)

Summary of the Role: The UK National Director will be trained as a BCM missionary and will be responsible for the overall development of BCM's Bible Club, discipleship group and camp ministry in the UK. For Northern Ireland and Scotland this will involve working alongside the existing leadership in these areas to support and develop ministry. For England and Wales, the role will be primarily a pioneering one, developing new children's ministry opportunities in areas of identified need. The UK Director will ensure that this is carried out in a manner which furthers the vision, mission and charitable objectives of BCM UK, and which is consistent with the doctrinal beliefs and core values of the organisation.

Key Roles & Responsibilities

The UK National Director will be responsible for:

- 1. Pioneering Bible Club, discipleship and camp ministry in England and Wales.
- 2. Implementing and monitoring strategic plans in partnership with missionaries and the Anchor Trust.
- 3. Promoting the ministry of BCM in the UK through deputation, literature and online methods.
- 4. Recruiting volunteers and missionaries who will facilitate the development of the work.
- 5. Developing good working relationships with the missionaries and trustees/directors in each area of the UK.
- 6. Supporting missionaries in managing their workload.
- 7. Ensuring missionaries are accountable to, and involved with, a local church.
- 8. Ensuring resources, including financial resources, are effectively managed.
- 9. Helping to resolve issues which arise, and which cannot be resolved locally.
- 10. Maintaining links with the wider BCM family through attending conferences.
- 11. Keeping relevant skills and knowledge updated.
- 12. Remaining familiar with UK policies and procedures relevant to the post and updating these as necessary.
- 13. Any other duties as agreed with the Anchor Trust.

The UK National Director will be appointed by the BCM UK Anchor Trust; their appointment will then be ratified by the President and International Board of Directors of BCM.
